1	Convention update	Satya Patnaik gave an update on convention progress. Volunteers are working hard with the planning to ensure the maximum utilization of three-days timing for both the venues. They are planning to coordinate with the chapters. He requested all the chapter presidents to provide cultural coordinators and other contacts. He also emphasized on promoting youth activities for the convention. He requested BOG for life membership promotion to encourage non- members to become OSA members. A motion was brought by Sikhanda Satpathy and seconded by Sabita Panigrahi to start a membership promotion with life membership fees of \$200 between Jan 15-Apr 30, 2014 subject to constitution review on membership to make sure that none of the rules are violated. It was voted for unanimously.	
2	Phailin Relief Fundraising	Tapan Padhi gave an update on Phailin fundraising. He said that OSA has requested the chief minister relief fund to do some infrastructure work on behalf of OSA. Discussion is in progress with the help of Hari Patra, Annapurna Pandey and Sanat Patnaik. Sikhanda Satpathy added that it was a successful fundraising because of a combined effort from BOG and volunteers. He thanked Niharika Mohanty as she took the initiative and leadership to da fund raising event in California area. BOG members expressed appreciation for her effor to organize a successful fund-raising event, being a second generation Odia.	
3	Jyoti Pattanaik update	Prashanta Ranabijuli updated that OSA has raised around \$8000. Sabita mentioned that Sagarika is very appreciative of all the help and support she is getting from Odias in North America. Tapan Padhi mentioned that the help from OSA members is very commendable.	
4	Financial Report	Prashanta Ranabijuli asked if anyone has any question on the report he had circulated earlier. He mentioned that OSA membership stands at 1090 now. Colorado is in the process of forming a new chapter. BOG members suggested that we should ensure that we follow all the requirements to form this chapter.
